1. Context

The multi-donor project "QUIS - Better Goods and Services" on 'Enhancing Company's Competitiveness through Quality Infrastructure' in Georgia (hereafter - QUIS) is jointly cofinanced by the European Union, the Federal Ministry Economic Development BMZ and Czech Development Cooperation (CDC) and implemented by GIZ and CzDA. The project timeline is scheduled till January 31, 2027.

Overall objective of QUIS is to ensure safety and promote inclusive and sustainable economic growth in Georgia through improved competitiveness of the private sector and implementation of the DCFTA and its EU related commitments, with a particular focus on business, trade, environment, and better skills matching.

Elevator use is a daily reality for thousands of citizens in Georgia, particularly in urban areas and bigger cities. However, public awareness of elevator safety remains low, resulting in frequent misuse, preventable accidents, and heightened risks to both adults and children.

To address this issue, QUIS project seeks to launch a comprehensive Elevator Safety Campaign. The campaign will raise awareness of safe elevator behavior, inform users of elevator inspection importance, raise knowledge of responsible institutions of elevator safety and understand more about the standards that are crucial when it comes to elevator safety.

The primary objective of this assignment is to contract a qualified communications agency to design, produce, and implement a coherent, multi-channel campaign that delivers impactful messages and visuals in an engaging and accessible manner. The campaign will use creative communication tools, digital engagement, and media outreach to promote safe practices, foster behavioral change, and highlight the importance of preventive action in ensuring elevator safety.

2. Tasks to be performed by the contractor

The contractor is responsible for providing the following deliverables:

Visual Identity & Communication Direction

- Develop a campaign identity.
- Design a consistent color palette, fonts, and graphic elements.
- Development of tagline of the campaign/key messages and areas to communicate

Design Materials

- Design stickers/posters for elevators and lobbies.
- Develop flyers/brochures for distribution about elevator safety
- Produce graphic poster with "do's and don'ts. In the elevator"

Landing Page development



- Develop and maintain a simple, mobile-friendly landing page, including domain registration and hosting setup, ensuring full alignment with the campaign's visual identity. The contractor shall cover all design, technical development, and integration costs, including embedding videos, posters, and downloadable materials.
- Integrate QR codes for tracking page visits.
- **Produce 3 short (up to 30-40 sec) videos**/graphical for Instagram and Facebook about illustrating correct vs. unsafe behavior in the elevator, 1 video about the safety of the elevator, 1 video about responsible parties for elevator standard compliance.
- **Develop interactive digital content** in partnership with popular media outlet (e.g., quizzes, reels) on "What to do if the elevator gets stuck?" "tips for compliance measures for elevator safety"
- **Articles in media,** up to 3 articles with different focuses around elevator safety, content created and published in the media.
- Develop a campaign wrap-up success video showcasing activities, events, and success stories.
- Propose and implement campaign hashtags (for instance #ElevatorSafety, #SafeRide).

Media Engagement - Organize 1 TV media appearances in Afternoon or relevant business shows.

Final report as a deliverable that all activities have been completed.

1. Technical-methodological concept

• Requirements on the format of the tender

The structure of the tender must correspond to the structure of the ToR. The complete tender must not exceed 10 pages (excluding CVs). If one of the maximum page lengths is exceeded, the content appearing after the cut-off point will not be included in the assessment. External content (e.g. links to websites) will also not be considered.

The CVs of the personnel proposed in accordance of the ToRs must be submitted using the format specified in the terms and conditions for application. The CVs shall not exceed 4 pages each. They must clearly show the position and job the proposed person held in the reference project and for how long. The CVs can also be submitted in English.

As the contract to be concluded is a contract for works, please offer a fixed lump sum price that covers all relevant costs (fees, expenses etc.). The price bid will be evaluated on the basis of the specified lump sum price. In addition, please also provide the underlying daily rate. A breakdown of days is not required.
